3rd Sector qualification in Europe

A GRUNDTVIG PARTNERSHIP PROJECT



This project main objective is to identify and exchange 3rd Sector qualification experiences at an European level, involving partners who's experience will create an added-value towards the deepness and improvement of this sector qualification activities.

Third meeting, Berlin, 4-5 June 2012

Technologie-Netzwerk Berlin e.V. (TECHNET) hosted the third partners meeting of the Project Q3.eu. The German partner was welcoming its Italian, Cypriot and Portuguese partners in order to discuss training, quality and certification issues in the 3rd sector from the point of view of third sector organizations, social enterprises, and training providers.

For this meeting all partners presented papers on training and quality issues in 3rd sector/social economy. The partnership also reviewed the goals, working plan, and prepared the interim evaluation.

During the meeting there were made presentations on good practice examples of social enterprises, training courses for the third sector and the social economy, and auditing procedures. This time, an intensive discus-

sion brought intense light into our whole project.

Q3.eu project partners met at TECHNET's head office in Berlin. The partnership took part in workshops organized by the hosting partner. These workshops had as main goal to demonstrate some examples of good training service providers, practical examples of qualification in the 3rd sector and some examples of improving the management of organizations in the 3rd sector itself, including the Social Accounting and Audit of SAN.

Moreover, the Portuguese partner University of *Trás-os-Montes e Alto Douro* co-ordinated the Project Q3.eu focus group methodology for the interim project.



Social dinner at "Die Weltküche"

An international meeting at the multi-cultural restaurant Die Weltküche in Berlin, run by the social enterprise "Graefewirtschaft", took place in the borough of Kreuzberg. This enterprise was set up collectively by migrant women from Ecuador, Serbia, Syria, Turkey. It also runs a catering service, predominantly for schools in the neighbourhood. This enterprise start-up was accompanied by BEST, the Berlin Development Agency for Social Enterprises and Neighbourhood Economy which is run by TECHNET.



3rd Meeting Conclusions:

The contexts in which the partners work, are very different and accordingly, the learning approaches are different as well. But the different approaches were interesting and obviously important for the practices in other countries.

The focus these days was put on the issues of the local social economy and its enterprises. The social enterprise approach is a more sustainable and efficient way of acting economically than the one carried out in the public and private sector as it does not depend on transfers, and on a high return on investment.

By investing into people, it produces a social benefit for its beneficiaries and the whole society.

Beneath learning subjects which are common for most of private enterprises, this ever-growing sector in the European Union needs additional competences and qualification. The European Learning Package Local Social Economy is designed to develop specific micro-economics for this sector.

The same applies for the auditing procedures of those enterprises. In parallel to financial audits, it is recommended to carry out Social Accounting and Auditing which eventually leads to a Social Audit (www.socialauditnetwork.org.uk/).

Certification issues also relate to learning, and management, and discussion on this is going on...

A two-day workshop on 3rd sector training and qualification



Procedure of the Meeting in Berlin

On the 4th of June, Guenther Lorenz presented the host's organization - which is an intermediary social enterprise, serving the local social economy. This presentation was followed by a survey from Dr Karl Birkhoelzer, on the third system / social economy in Germany and the EU. Another presentation on a European Curriculum for the Local Social Economy which leads to a certificate, at the Potsdam University of Applied Sciences www.cest-transfer.de (co-funded by the EU Leonardo ITP Programme), was given by Dr Lorenz.

A project monitorization, including the Rome meeting evaluation results, dissemination issues, and the networking and communication followed. In the afternoon, the social audit approach, a social accounting and auditing procedure, adapted to the needs of 3rd sector organizations, social enterprises included, finalized the working programme. In the evening, the guests were invited to a meal in a multi-cultural social enterprise in the borough of Friedrichshain-Kreuzberg.

Next morning, the Cypriot Neuroscience & Technology Institute presented their organization's goals, and the training and certificates they provide for their clients, in-

cluding their didactics and methodologies.

Thereafter, the partners were asked by the representative of University of *Trás-os-Montes e Alto Douro*, in a focus group discussion, to detect important information for the interim evaluation. Organized in a very well structured way, the benefits of the projects, on some problems and recommendations how to overcome them, came out of this discussion.

At the end of the meeting, a final balance of the meeting was made:

- Determination of the activity report, evaluation report, and the interim report, and next newsletter,
- Tasks and timescale definition for the future,
- Preparation of the 4th partnership encounter, including its objectives, activities, and expected results, and the timescale definition.

Our discussion was vivid and creative, bringing about more clarity about the subjects we spoke and richness of experiences, our partners could share with us.

TECHNET's contribution to the Q3.eu project will be concretely in realizing the products foreseen by the project which will be disseminated and promoted.

TECHNET particularly took over responsibility to

- Develop a typology of training schemes used by and / or developed for the Third Sector / Social Economy
- Analyze the pro and cons of existing quality management systems available in the countries of our partners. This includes also the certification systems used by the Third Sector / Social Economy



Technologie-Netzwerk Berlin e.V. (an association certified as working for the public benefit) is a network of individuals, initiatives and organisations working towards the common goals of research, training and education in the areas of need-based local and regional technology, economic development and employment strategies. It runs an *Economic Self-Help Training and Education Centre* as well as an *Interdisciplinary Research Group (IRG) 'Local Economy'*. A key focus of the research and development activities is the creation of jobs through the establishing of social enterprises. Via its work, TechNet has built up a wide range of contacts and co-operative relationships with similar projects, agencies, public sector bodies and enterprises. Social management, social marketing and social accounting are the main tools for developing social enterprises which want to use and build social capital.
